MEMBERSHIP MODULE



The Sacco membership module consists of members both from within the common bond and outside. The prospective members fill a registration form, which they sign, and present to the office in order to enroll as members.

The office processes the applications and the applicants asked to pay the membership application fees after which they become members of the society.

CONTRIBUTION MODULE



One of the ways of raising Sacco revenue is by way of member's contributions. Baraza Sacco enables a Sacco to efficiently and easily manage member's contributions.

The module ensures that their members get a notification on their contribution either through a SMS or an email.

LOAN MANAGEMENT MODULE



The functionality of loan management is primarily to manage loans to the members. Every Sacco has different types of loans in line with the Sacco's rules and regulations.

Loan management module on Baraza Sacco helps in approving the loans the members have requested also helps in loan repayment, which can be either through payroll, direct bank deposits, standing orders, cash or cheque depending on the Sacco rules.

Other functionality of loan management module includes;

- ✓ The Sacco system allows any specific type of loans definition.
- ✓ Ability to maintain multiple open loans at a particular period.
- Support a twelve- period or optional period fiscal year.
- Perform real time updating of loan payment information according to the loan payment plan.
- V Posts all loan details and payment financial aid disbursements
- Calculates loans based on Sacco enrolment or other criteria.
- The system also provide facilities for a defaulter subsystem to maintain the members records, calculate surcharge and penalty charge and initiate actions on hold for some Sacco members.

LOAN INTEREST MODULE



Interest is the money realized after the member's repayment of loans or if the Sacco has other business.

Loan interest module has the ability to customize the following reports;

- ✓ Visually show borrower interest account calculation.

The functionality of this module is primarily used to manage the shares of the members. The members once enrolled into the Sacco are expected to contribute a set minimum amount in order to qualify for the services of the Sacco.

Additionally, the Sacco maintains part of the contributed amount as non-withdrawableshare capital. A member may also offset part or all his deposits with a loan on application and approval by the Sacco. The members can also buy shares from other members who may wish to transfer their shares.

A member may also fully withdraw and have his deposits refunded and retain only the non-withdraw able shares. A member can also top up his shares/deposits by contributing a onetime amount, which is then credited to his membership account in accordance with his/her instructions

The module is equipped with various critical alert notifications including overdue payments, payment due dates. Running balances and statements are available to every member using the online portal.

BULK SMS & EMAILS MODULE



The system will send notification messages during loan approval, guarantor approval and for any other event suggested by system users/ owners. Announcements can also be scheduled to all members via the svstem.

SMS guery facility is also available for members to guery information like loan status, total contributions and other additional information as requested by the client.

INVESTMENT MODULE



This module addresses cases where a community of likeminded people pools their money and knowledge together to fund a particular investment.

The investment opportunity is identified and valued. Invitations for recruitment is sent out to all potential members who would either agree or decline the offer. Members are then enrolled into the scheme. Based on the investment amount and the funding timeframe, members set individual contribution amount and agree on an investment schedule of raising funds.


